

### DEVICES, PARTNERS AND PRACTICES THAT HELP CREATE SAFER COMMUNITIES



- Anything can happen in any community so no community can be guaranteed "safe". The goal is to make a community as safe as possible within reason, budget, and commitment by the people that live there with the help of security **Devices**, engaging good **Partners**, and effective **Practices**.
- Devices Cameras, Automated Kiosks, Alarms, (Security Personnel like Guards and Pool Monitors)

#### Partners –

- Vendors Different types with different functions
- Homeowners (including BODs) investing time in education, buy-in to security goals, and yearly investment
- Law Enforcement (For Education and if living in the community)
- Practices Putting it all together. Devices, Partners, and Budgeting for Security effectively all help determine how safe a community can be



### THE BASICS OF A CAMERA


They All Boil Down to 3 Main Components

- Lens: Wide Angle, Zoom, Vari-Focal, Standard (something in between) are the most common. Determines how wide the camera will see and how close the subject will be
- Chip or Sensor: (Complementary Metal Oxide Semiconductor "CMOS" CHIP).
  Determines the resolution measured in Mega Pixels or MP. More on that later
- Housing or Case: Bullet, Turret, Dome, 2in1, PTZ. Usually the same parts as above, just different shapes to fit them in to. Chosen based on a variety of variables like protection (vandal dome) ease of adjustment (bullet), and versatility (PTZ). See previous slide



### 4K? - 1080P? – 2MP- WHAT DOES IT ALL MEAN? Mega Pixel

A pixel is the smallest unit in a digital display. Each pixel is made of sub pixels that emit red, green and blue color. A Mega Pixel, abbreviated MP is 1 million pixels. So 2MP Mega Pixel is 2 million pixels.






## **MEGA PIXEL AND ASPECT RATIO**

#### Aspect Ratio

- Aspect Ratio is the ratio between the with and the height of an image. The standard ratio for the cameras we use 16:9 or means 16wide by 9 high.
- So 4K and 8K refers to the aspect ratio, and Mega Pixel refers to how many pixels are in that aspect ratio's space. The larger the aspect ratio, the more pixels in it and the higher the resolution
- The easiest way to define resolution is by the number of Mega Pixels since the aspect ration will correspond







#### Is there a difference between 2 MP (aka 1080p) and 8MP (aka 4K) video resolution? *It depends on the distance*




### Camera 10ft 20ft 30ft 40ft 50ft Resolution 2MP (1080P) 8MP (4K)

#### 2 Mega Pixel vs 8 Mega Pixel

- When comparing the difference between 2 Mega Pixel and 8 Mega Pixel, the resolution difference is not significant at 10 or even 20 feet. The difference becomes much more apparent at 40 to 50 feet and beyond
- Variables like distance, light, age of camera, and the direction the camera faces (East/West) also play an important part in image quality over time


### **PARTNERS - VENDORS**

Questions for an HOA Camera Vendor



- Does the company have a Private Security License with the Texas Department of Public Safety?
- How much experience working with HOAs specifically? References with multiple Management Companies and Communities?
- Does the company sell or lease camera systems, or both?
- What's the response rate for service calls? If there is a fee for service calls, what's the cost?
- Are you going to get "nickel and dimed" for add-ons or coming out for adjustments to settings, passcodes, training?
- How long has the company been doing business with HOAs in DFW?





## **PARTNERS – HOMEOWNERS**

Homeowners and BODs Doing Their Part to Keep Communities Safer



- BODs: Get cameras in the budget as a reoccurring investment every year, not just 'one and done'
- Alarm systems at homes. On at night and when not home
- Cameras at front (doorbell), back and side doors.
- Cars off the street if possible, locked at all times when not in garages
- Closed garages. Assume all items in front yard fair game for theft
- Locks on gates to back yards. Security and/or dog signs
- Note for to shippers to put packages in places out of sight from the street if possible
- Not announcing future events and vacations on social media





## **PARTNERS – LAW ENFORCEMENT**

Working with Local Law Enforcement





- Invite local law enforcement officers to speak and do Q & A at HOA Meetings.
  Popular topics are often:
  - What to watch out for specific to your city / HOA community
  - Is it a police matter or HOA matter. It helps to know the difference
  - Local laws regarding speed bumps/ fireworks/noise etc. are all helpful to those discussions
- Find out the most recent common crimes in your city and community.
- Find out what types of crimes and mischief local police are willing to pursue, what they will need, and plan around that


### WHAT THE CAMERAS SHOULD BE LOOKING FOR

#### The Most Common Crimes We See Across DFW Are:



Door Puller caught on old 2MP camera

- Door Pullers: On cars on streets
- Pool: Vandalism, Theft, and Mischief (gate riders, glass, furniture "christening", loud music, fights) at Pools and Amenity Centers
- Porch Pirates
- Garage Opportunists
- Car/MotorcycleTheft
- Home Burglary



It varies by community, but this list is in order of occurrence and has stayed consistent across DFW, based on our experience only

#### Why Have Cameras in The First Place?



- New cameras with Active Deterrence address Crime and Mischief BEFORE IT HAPPENS! New options to use lights, live or recorded 'talk down', sirens, and push alerts have changed the game
- Have a way to pursue criminal activity with usable video evidence
- Have a way to inform parents their kids could be doing something dangerous
- Provide a better understanding of trends, traffic flow, and amenity usage that could help with security

Why Not Just Have A Homeowner Install Cameras For Free/Cheap?

- COI, W9, Licensing HOA camera vendors must have proper insurance, tax info, and DPS License
- Maintenance and Service Calls Is the homeowner in a service contract for SCs?
- Continuity What happens if the homeowner moves (with passwords and access), or just quits and is not willing to service the equipment?
- Experience With HOAs Working with HOA Boards, Rules, and Expectations
- Access to The Newest Equipment Fresh from the latest security trade shows, not the back of the shelf from the big box store
- Conflict of Interest Will it create problems with other homeowners and BOD down the road?

#### How Long Do Cameras Last?

Over time, the sun breaks down almost everything, including the computer chips inside security cameras. This creates grainy, washed-out video and still images. In our experience, cameras facing East and West are typically compromised sooner with the rising and setting sun.

The sun, location, weather, brand, and level all effect the life of a camera, so there is not an expiration date. More than 3 years and less than 6 or 7 is a fair estimate

How Much Should Cameras Cost? It Depends On...

- Your security goals
  - The number of spaces that need coverage
  - The resolution of the cameras used
  - The number and type of cameras used
  - The brand of equipment used
- What the budget is (there is a budget for this right?) Getting "the best bang for the buck" is critical in working with any budget
- Where are they wanted Is access for placement difficult, are they high up, are the surfaces challenging?
- Who is selling and installing them Some vendors have more overhead than others, and provide quotes that don't cover essentials, so its hard to tell what a job should really cost

Look for standard pricing with clear costs for additional equipment or services



#### What's In The Future for HOA Cameras?

- More Not Fewer HOA Cameras
- Active Deterrence A proactive not reactive approach to crime and mischief
- White Light added to infra red "IR" lights at night – Seeing color at night helps distinguish clothing and other important features
- Better AI, Less False Events Distinguishing between animals, people, clouds or shadows, cuts time out of reviewing video
- Better Homeowner acceptance of cameras around the HOAs as they start to use them in their own homes



### Cameras are a necessary tool in today's world; it's important to embrace them, get educated on them, and use them strategically and judiciously

Having community buy-in on cameras, choosing a competent and dedicated vendor, prioritizing budget for them, and having the right equipment are great steps in having the safest community possible!
